


# TP9375 60 11 & TP9375 60 12 Master Equipment® Stainless Steel Walk-in Tub

#### **Parts List:**

- (A) Tub Basin (1)
- (B) Tub Base (1)
- (C) Small Plastic Tub Rack (1)
- (D) Large Plastic Tub Rack (1)
- (E) Drain (1)
- (F) Strainer (1)
- (G) Drain Plug (1)
- (H) Rubber Gaskets (2)
- (I) Locking Ring (1)
- (J) Plumbing Hose (1)



## Assembly: Steps 1-2

- 1. With help from a friend or colleague, pick up the Tub Basin (A).
- Line up the rim on the bottom of the Tub Basin (A) with the edges of the Tub Base (B). Gently slide the Tub Basin (A) into place on the Tub Base (B).



### Assembly continued: Steps 3-5

- 3. Slide the Rubber Gaskets (H) around the Drain (E) and install the Drain (E) into the plumbing hole.
- Screw the Locking Ring (I) onto the bottom of the Drain (E) to securely lock it into place in the Tub Basin (A). Locking Ring (I) is used to secure the Rubber Gaskets (H) in place under the Drain (E).
- 5. Screw the Plumbing Hose (H) onto the bottom of the Drain (E).





## Assembly continued: Step 6

6. Place the Small Plastic Tub Rack (C) and Large Plastic Tub Rack (D) into the basin of the tub.



#### **CARE INSTRUCTIONS**

Rinse thoroughly after bathing pet. Make sure tub is clean and dry after use. Clean with mild soap or a stainless steel-approved cleaner only. Do not use harsh or abrasive cleaners, bleach, or tools with metal or textured parts, as these can scratch or damage the tub.
